This upcoming meeting of the Board of Trustees promises to be among our most consequential thus far. This email is intended to provide you information and materials pertinent to the matters to be taken up at the meeting and for future reference. The Agenda contains Attachments 1-9. We do not expect you to read everything in advance of the meeting, but the Attachments referenced will allow you to follow the speakers who may reference specific attachments.

#### **Open Session**

We will commence and continue in open session from 5 p.m. to approximately 7 p.m., following the attached Agenda. Upon completion of identified new business tasks of the Agenda, we will notify the public of our intention to proceed to Executive Session for approximately thirty minutes.

All Committee Chairs or their designees will be able to report during the open session, though I would ask everyone to be as succinct as possible and limit their remarks to five minutes or less.

During this period you will be briefed on the <u>Calendar of Critical Launch Activities</u>, prepared by the Administrator of the 120-Day Plan, Dr. Church, with the input of the candidate for Interim President and Dr. Polonio. <u>See</u>, Attachment 1.

You will also be briefed on the <u>Temporary Administrative Hiring Procedures Checklist</u>, and the <u>Temporary Procedures for Consultant Services</u>, prepared by the Consultant to the 120-Day Plan, Dr. Polonio, with the input of the candidate for Interim President and Dr. Church <u>See</u>, Attachment 2 and 3.

The policies and procedures set forth in the Attachments are based on the diligent work of our professional team and the input of the candidate for Interim President. The Board Committees have been an integral part of this effort by providing oversight. Vice Chair / Academic Chair Cheryl Rush Dix and Personnel Chair Tom Benson will each be making motions to advance this process.

#### Executive Session and Return to Open Session

In Executive Session we will follow upon the work of the Board and take up matters related to the terms of the proposed agreement with the candidate for Interim President. We will thereafter return to open session to consider action on the matter.

In closing, I would note that the dedication of each of you to this effort brings us to an important milestone. The measures we have pursued and are now addressing signal the required placement of operational authority into the hands of a strong Interim President. Our unlikely success at meeting this goal in January preserves a key benchmark in our effort to seat the inaugural class in September 2021. Moreover, these steps allow us to aggregate the significant resources that have been placed at our disposal so that we might broaden our team of skilled community college advocates for Erie County.
